BOARD PRESIDENT'S REPORT

The Board President, Dr. Barbara Campbell summarized her attendance of the National Board of Podiatry Medical Examiners (AMPLE). The exam is the clinical skills podiatric exam for the second part of the National Boards that individuals take, which they must pass. The exam determines the competency level for students to enter into residency. They evaluate the communication and podiatric skill level to see if the criteria developed shows that individuals have minimal level of competency.

LEGISLATIVE UPDATE AND DISCUSSION

Kristina Gomez, Executive Director provided an update regarding Arizona State Legislature bills, which includes SB 1086, SB 1096, SB 1123, SB 1103, SB 1108, SB 1105, SB 1029, HB 2075, HB 2118, HB 2231, HB 2463, HB 2519, HB 2113, HB 2068, HB 2058 and/or any other related legislation.

REVIEW, DISCUSSION AND POSSIBLE ACTION REGARDING PROPOSED CHANGES TO BOARD STATUTES AND RULES

Dr. Joseph Leonetti discussed with the Board possible modifications to A.R.S. § 32-854.01(11). The purpose is to modify the statute to allow the podiatric community to purge patient paper records after six years, given that most physicians are moving to electronic record keeping. The current statute requires physicians to maintain records for seven years, which is not consistent with other states. Dr. Leonetti recommended for the Board to continue discussions of proposed modification for next Legislative session.

REVIEW, DISCUSSION ON MEDICAL PRACTITIONER REGARDING DISCRETIONARY UP-CODING BY MEDICAL CODERS / BILLING

Dr. Barry Kaplan presented information regarding coding. The concern are physicians who work for groups or corporate practices having no control over the change in coding. It is possible that physicians would not know there is a change in coding until a complaint is filed for billing issues. The only way physicians have control on coding would be based on physician notes. There is a need for some protection for doctors.

EXECUTIVE DIRECTOR'S REPORT

The Board reviewed the budget, agency operations, and complaint log with Kristina C. Gomez. The Board recognized Dr. Barry Kaplan and Dr. Joseph Leonetti for their years of public service with the Board.
