#### **OPEN SESSION MINUTES**

### May 9, 2018

#### **OPEN SESSION**

The meeting was called to order at 8:41 a.m. by Dr. Barbara Campbell. The following order of business was then considered:

#### DECLARATION OF CONFLICTS OF INTEREST – A.R.S. § 38-503

No new conflicts were declared.

#### ITEMS FOR BOARD REVIEW, DISCUSSION AND POSSIBLE ACTION

Investigation File(s)

18-14-C; Burke, William, DPM

Dr. William Burke and his attorney were not present. The complainant participated by phone. Dr. Jerome Cohn was present and summarized his investigator's report. Dr. Cohn did not substantiate the issue. The extensive records provided were complete and comprehensive. The care with the cortisone shot was sufficient, and Cigna has multiple physicians and office staff available when the doctor is out of the office. The complainant made remarks about his health and his visit with the doctor.

After discussion, a motion was made by Dr. Joseph Leonetti, and seconded by Dr. Barbara Campbell and passed unanimously to dismissed the case due to no violations of Board Statutes and Rules.

#### 18-08-C; Farrell, Patrick, DPM

Dr. Patrick Farrell was present along with his legal counsel, Kimberly Kent. Dr. Dedrie Polakof was present and summarized her investigator's report. Dr. Polakof concluded that the complaint is unsubstantiated. The patient testified before the Board summarizing her past and current health condition as a result of the care by Dr. Farrell. The patient underwent bunion surgery for the right foot, which resulted in four follow up surgeries. The patient now experiences constant nerve pain as a result of the surgeries. The Board was concern with Dr. Farrell's decision of not ordering CT/MRI, nerve conductions study, or consulting with a specialist.

A motion was made by Dr. Joseph Leonetti, seconded by Dr. Barry Kaplan and passed unanimously to issue a non-disciplinary consent agreement and interim order for 12-month chart review regarding all deep nerve decompression procedures. If the Board finds any issues during the monthly chart review, the Board will issue a new complaint.

#### Governor's Special Legislative Session - Opioid Epidemic Act (S.B. 1001)

The Board discussed the Governor's Special Legislative Session Opioid Epidemic Act and how it impacts podiatry. The required implementation of continuing medical education regarding opioids will impact renewal cycles. The Board does have the ability to waive the three required credit hours until the next renewal cycle.

After discussion, a motion was made by Dr. Joseph Leonetti, and seconded by Dr. Barbara Campbell and passed unanimously to waive the opioid three credit hours of CMEs until next year.
