Ms. Broaddus provided a summary stating that Dr. Bland self-reported a driving under the influence charge in July 2019. The Board voted to table the matter until the Court makes a determination in the case. Subsequently, on December 13, 2019, the Board office received email

correspondence from Robert Sorrentino, Chief Medical Officer at Tuba City Regional Healthcare Corporation (Tuba City). The correspondence indicated that Dr. Bland resigned from Tuba City while under investigation. The Investigation was initiated due to allegations that Dr. Bland was consuming alcohol while on call. On December 17, 2019, the Board office received additional correspondence from Tuba City. The correspondence provided additional details regarding the Tuba City investigation pertaining to Dr. Bland.

Dr. Bland and his attorney, Flynn Carey, Esq., were present. Mr. Carey requested to speak, made a statement and answered Board members' questions. Mr. Carey stated that the Tuba City investigation coincides with Dr. Bland's July 2019 self-report. Mr. Carey assured the Board that this was a one-time incident and that the correspondence from Tuba City is misleading.

After deliberation, Dr. Campbell made a motion, seconded by Mr. Rhodes, to open a Complaint to investigate the matter further. The motion carried unanimously, 4-0.
