OPEN SESSION

Dr. Campbell called the meeting to order at 8:31 a.m. The Board considered the following order of business.

DECLARATION OF CONFLICTS OF INTEREST – A.R.S. §38-503

There were no declarations of conflicts of interest.

Informal Hearing; Complaint No. 21-06; Alan Shih, DPM

This was an Informal Hearing from a complaint regarding big toe pain and fungus with an ingrown toenail.

Dr. Shih was present telephonically and his attorney, Kenneth Moskow, Esq., were present. Mr. Moskow requested clarification on the Informal Hearing process. The Complainant, J.P., was not present. Board members' introduced themselves. Dr. Campbell reviewed the Informal Hearing process.

The Board's Investigator, Dedrie Polakof, DPM, was present telephonically and provided a summary to the Board.

Dr. Campbell swore Dr. Shih in. Dr. Shih and Mr. Moskow requested to speak, made a statement and answered Board members' questions. Dr. Shih stated the patient presented with toenail fungus and pain. Dr. Shih stated that he pre-ordered a vascular test before seeing the patient. Board members' asked Dr. Shih to provide his definition of Informed Consent. Dr. Shih answered. Board members' asked Dr. Shih if he pre-orders vascular testing on all patients. Dr. Shih stated he does not. Board members' asked Dr. Shih why he chose not to inject the ankle before taking the x-ray. Dr. Shih stated it is not his normal practice. Board members' asked Dr. Shih to explain why he gave the cortisone injection when there was no apparent need for it. Dr. Shih answered. Board members' asked about the patient's pain and whether he addressed the patient's pain with the patient. Dr. Shih answered. Board members' indicated that Dr. Shih should be performing more nerve examinations. Board members' asked Dr. Shih if the patient was given other options other than cortisone injections. Board members expressed concern that Dr. Shih did not sign the patients February 22, 2021, record until March 5, 2021. Dr. Shih explained that he had handwritten notes and other entries to be added to the February 22, 2021, record. Board members expressed concern that Dr. Shih gave the patient a lot of information without explaining everything resulting in a lack of communication. Dr. Shih opined that his care of the patient was within the standards of care.

The Board deliberated and expressed concern with Dr. Shih's record keeping and documentation, Informed Consent and lack of communication.

After deliberation, Dr. Campbell made a motion, seconded by Dr. Eulano, to issue a Non-disciplinary Order for continuing education for nine (9) hours with three of those hours in record-keeping and documentation, with three of those hours in communication and with three of those hours in Informed Consent. The nine (9) hours of continuing education are in addition to the required continuing education hours for license renewal. The nine (9) hours shall be completed within six (6) months from the date of the Order. The motion carried unanimously, 4-0 on a roll call vote.
