Application for Telehealth Registration as a Podiatrist, \$50.00 fee

Qualifications for a temporary license include the following:

1. Holds an active and unrestricted license in podiatric medicine in a State, Territory or Possession of the United States
2. Has not had a license suspended or revoked by a health profession regulatory Board in this or any other jurisdiction. License has not been subject to any past or pending disciplinary proceedings in any jurisdiction.
3. Declaration of all active and past professional licenses and certificates issued by this state, another state, district or territory of the United States.
4. A completed Arizona Statement of Citizenship and Alien Status for State Public Benefits form.
5. A self-query from the National Practitioners Data Bank, www.npdb.hrsa.gov.
6. Evidence of professional liability coverage.
7. You must designate a duly appointed statutory agent for service of process in this state.
8. If you hold a DEA certificate of registration you must submit a copy. If you prescribe a controlled substance you must register with the controlled substances prescription monitoring program (CSPMP). You may register on the Arizona Pharmacy Board’s website, pharmacy.az.gov.

If you are actively licensed in another jurisdiction you are exempt from having to register to practice telehealth in Arizona if the services are provided under one of the following circumstances:

- In response to an emergency medication condition.
- In consultation with a health care provider who is licensed in this state and who has the ultimate authority over the patient's diagnosis and treatment.
- To provide after-care specifically related to a medical procedure that was delivered in person in another state.
- To a person who is a resident of another state and the telehealth provider is the primary care provider or behavioral health provider located in the person's state of residence.
- 2. The health care provider provides fewer than ten telehealth encounters in a calendar year.

With respect to licensing decisions, please note that A.R.S. §41-1030 provides that:

B. An agency shall not base a licensing decision in whole or in part on a licensing requirement or condition that is not specifically authorized by statute, rule or state tribal gaming compact. A general grant of authority in statute does not constitute a basis for imposing a licensing requirement or condition unless a rule is made pursuant to that general grant of authority that specifically authorizes the requirement or condition.

D. This section may be enforced in a private civil action and relief may be awarded against the state. The court may award reasonable attorney fees, damages and all fees associated with the license application to a party that prevails in an action against the state for a violation of this section.

E. A state employee may not intentionally or knowingly violate this section. A violation of this section is cause for disciplinary action or dismissal pursuant to the Agency's adopted personnel policy.

F. This section does not abrogate the immunity provided by section 12-820.01 or 12-820.02

With respect to licensing, please note that A.R.S. §41-1093.01 provides that:

An agency shall limit all occupational regulations to regulations that are demonstrated to be necessary to specifically fulfill a public health, safety or welfare concern. Pursuant to Sections 41-1093.02 and 41-1093.03, Arizona Revised Statutes. You have the right to petition this agency to repeal or modify the occupational regulation or bring an action in a court of general jurisdiction to challenge the occupational regulation and to ensure compliance with section 41-1093.01, Arizona Revised Statutes.
