**ORDER FOR CONTINUING  
EDUCATION**

**(NON-DISCIPLINARY)**

8 At its meeting on September 9, 2020, the Arizona State Board of Podiatry  
9 Examiners (Board) voted to issue Kamran Farahani, DPM (Respondent), a non-  
10 disciplinary Continuing Education (CE) Order as a result of the documentation concerns  
11 raised in the complaint. The Board, pursuant to A.R.S. § 32-852.01(C)(3), determined  
12 that while the conduct was not of sufficient seriousness to merit direct action against  
13 Respondent, he would, as set forth below, benefit from completing a prescribed number  
14 of hours of continuing education in a specific practice area for purposes of providing him  
15 with the necessary understanding of current developments, skills, procedures or treatment.

16 **ORDER**

17 1. **IT IS HEREBY ORDERED** that within six months from the effective date  
18 of this Order, Respondent shall complete a minimum of six hours of Board approved CE  
19 in the area of appropriate documentation in medical records. The CE hours shall be in  
20 addition to the hours required for the annual renewal of his podiatry license, and can be  
21 completed online.

22 2. **IT IS FURTHER ORDERED** that Respondent shall, within six months of  
23 the effective date of this Order, provide Board staff with proof of attendance in satisfaction  
24 of this requirement.

25 3. Respondent's failure to timely comply with the Order will subject him to  
26 future disciplinary action by the Board. A.R.S. § 32-854.01(21).
